**WAITING PERIOD:** All contestants will call the headquarters each Friday morning, to check on surf conditions. There will be no refunds if you miss your heat. All alternates must pay an entry fee. No double entries.

**DIVISIONS:** Men's Open, Women's Open, Open Longboard (9' & Over, HLSA Regulation), and Open Body Board. Contest limited to first 80 entries. Contest limited to **BIG ISLAND RESIDENTS ONLY**. **ENTRY FEE:** Sixty Dollars (\$60), non-refundable, to be paid in cash, cashiers check or money order. **NO PERSONAL CHECKS**. Includes t-shirt. Payable to: **BIG ISLAND RESOURCE CONSERVATION & DEVELOPMENT COUNCIL**. Entry deadline June 2nd. Late entries will be charged an additional ten dollars (total \$70). **NO EXCEPTIONS**.

**PRIZES:** 10 round trips from Hawai'i Island to Oahu, plus 10 entries to a **PRO-AM EVENT** on the North Shore of Oahu. The number of trips and entries will be awarded proportionally to winners in each division depending on the number of entries in each division. **MEN'S DIVISION:** Unless you are rated in the WSL Hawaii System, Men's Open trips go to the top finishers of 18 years or younger.
